Admission Brochure for

MAud Program

Founded in 1983, Nanjing Audit University (NAU) is a unique financial and economic institute of higher education around the world that carries "AUDIT" in its name. Nanjing Audit University is also considered as one of the cradles of audit higher education in China. In 2011, Nanjing Audit University was authorized to be one of the first Chinese universities to grant Master Degree of Auditing (MAud) by the Academic Degree Committee of the State Council. In the same year, the Ministry of Education, the Ministry of Finance, the National Audit Office and Jiangsu Provincial Government jointly signed the agreement to co-construct Nanjing Audit University.

Located in the most economically and culturally developed Jiangsu Province in China and situated in the Provincial capital city of Nanjing, a city with nearly 2500 years of history and the capital for six dynasties in history, Nanjing Audit University enjoys a superb geographic location of facing the Yangtze River—the largest river in China and the third in the world, and with a national park—Laoshan National Forestry Park—at the back of the University. Apart from its premium education quality, Nanjing Audit University is also highly appreciated for its beautiful and picturesque campus view by not only its teaching staff and student body, but also by all the NAU visitors from all over the world.

Over its 33 years of development, NAU has established itself as an educational powerhouse in the arenas of auditing, accounting, finance, and economics while also excelling in the disciplines of management, law, liberal arts, science and engineering. The current student population totals around 16000, including over 300 postgraduates and 150 international students. Today's NAU consists of two campuses, Pukou and Mochou, covering a total area of 362 acres. CNAO's Audit Academy is as well set up on Pukou campus.

Nanjing Audit University actively advocates internationalization of education. The University has established extensive cooperation and exchange mechanism with international organizations such as International Organization of Supreme Audit Institutions (INTOSAI), Asian Organization of Supreme Audit Institutions (ASOSAI), Institute of Internal Auditors (IIA), and

supreme audit institutions of ten-odd countries including the U.S.A., U.K., France, as well as colleges and universities of Europe, North America, Oceania and Africa. NAU has been recognized as the only Partner University of IAEP (the Internal Auditing Education Partnership) Program in China. NAU cooperates with the Association of Chartered Certified Accountants (ACCA) to foster international CPAs and has been granted the title of "The University cultivating most ACCA talents in the world" and Platinum Status as training provider by the ACCA Headquarters. NAU started to enroll international students since 2005 and now international students from more than 30 countries pursue their undergraduate, graduate or language study.

With a strong manpower team of over 1300 staff members, 894 are engaged in teaching and research, among them 381 with Ph. D. degrees and 118 full-time professors. In the past five years, more than 650 teaching staff members went abroad visiting world-famous universities and SAIs for academic exchange, or taking part in training programs, and 62 teachers were engaged in UN audit programs. Over 2000 students have visited foreign universities or institutes on exchange programs, or attended international conferences, academic competitions or overseas voluntary activities. More than 100 foreign experts and scholars including Nobel Prize Laureate for Economics, the Secretary General of INTOSAI, Heads of SAIs of USA, France, Morocco, Tanzania, etc., have been honorably invited to visit NAU to deliver lectures or conduct academic exchanges, and some of them were conferred honorary title of professorship of NAU.

3. Objectives

Nanjing Audit University's MAud Program aims at cultivating high-level and applied talents who understand the fundamental conditions of China, have sound professional ethics and good academic morality, master systematic knowledge and techniques of modern auditing and its related fields, possess good adaptability, sound judgment and problem-solving abilities in audit field, command adequate computer skills, understand basic Chinese language and have acquired understanding about Chinese history and culture.

III. MAud Program Features and Advantages

- 1. Small scale of class size for MAud Program international students, 30-35 students per class.
- 2. All courses are conducted in the English language for MAud Program international students. Apart from instructors, honorary professors from NAU, senior auditors from CNAO will also conduct classes or deliver lectures.
- 3. For MAud Program international students, internship is to be done in China's government audit departments or offices. Students are also welcome in international conferences or seminars held at NAU.
- 4. MAud Program international students stay in NAU vibrant and diverse community consisting of both Chinese students and regular international students from abroad for better understanding, more cultural exchange, further communication, deeper friendship and more progress.
- 5. China-related courses are specially designed for MAud Program international students. In this way, MAud Program international students can immerse in the real Chinese cultural atmosphere and environment to learn more about Chinese culture.
- 6. Visits and trips can be arranged, upon the request of MAud Program international students and at their own cost, to benefit, on the one hand, MAud Program international students in learning the Chinese language, and on the other, in experiencing the rich and colorful folk customs in local Nanjing, the unique charm and famous sites of historic interest and scenic beauty of Jiangsu Province, and the profound cultural heritage in China.

IV. MAud Program Graduation and Degree

Having attained all the credits set in the Curriculum, passed the thesis defense, and met the requirements listed in *The Regulations on Academic Degrees of Nanjing Audit University for International Students*, MAud Program international students need to file an application for the degree as an MAud candidate. The candidates are to be conferred the Master Degree of Science in Auditing upon the approval of NAU'S Academic Degree Evaluation Committer.

V. Scholarship

Eligible participants for this MAud Program in Nanjing Audit University will be supported financially by Chinese Government Scholarship Auditing Master Program (CGSAMP) and possibly other local scholarship schemes. CGSAMP will cover tuition fees and accommodation fees (for dormitory on NAU campus), provide living allowance and Comprehensive Medical Insurance and Protection Scheme for International Students in China. CNAO would also consider the possibility of covering the cost for one round trip international airfare during the 2 years based on the principle of case-by-case application. Application for CGSAMP will be submitted according to the relevant rules governing CGSAMP, examined and approved by the CNAO, and issued according to the management measures for CGSAMP.

VI. Facilities

Convenient and comfortable campus life. MAud Program international students will be provided with single room accommodation, with air-conditioner, bathroom, shower, internet access and wifi. Different canteens and restaurants of various cuisines are within a few minutes walk from accommodation. Gyms, clinic, post office, courier service, shops, barbers and hair-dressers, laundry, photocopy shops, ATMs are easily accessible on campus. Bus and taxicab stops are just outside campus and business center is only a few minutes bus ride. Banks, subways, shopping malls, hospitals are just around the campus.
